Courses:

I. Course title: Memory, History and Theory: The Jews from Macedonia and the Holocaust

Lecturer: Ass. Professor Dr. Sofija Grandakovska

Short Description of the Course: The course is focused on aspects of the presence or the absence

of the Jewish narrative in Macedonia during the specific historical period marked as the Holocaust.

The discussion is centered at the challenge of embracing the semiotic position of reading the Jewish

discourse by including the following categories: a wider spectrum of the academic discourse

through the use of oral history as a way into historiography, the archival-documentary approach,

the questions and prospective answers to the socio-cultural, archeological, political, linguistic-

literary, artistic, sacral and memory-based practices, as well as their discursive (theoretical)

positioning of an interdisciplinary and inter-textual approach.

Lecture 1: The Holocaust: Memory and Place of Absence

Short description of the topic: How do we identify the strategies of memory and survival of the

memory when there are no Holocaust survivors? In terms of that: what constitutes the

memorialization of the Holocaust when we address the question of place of absence and permanent

loss of the memory-based practices and personal testimonies?

Lecture 2: Historical and Cultural Narratives of the Holocaust in Macedonia

Short description of the topic: The discussion is centered at the challenge of embracing the semiotic

position of reading the Jewish discourse by including a spectrum of the academic discourse through

the archival-documentary, socio-cultural, archeological, political and theoretical aspects.

II. Course title: Culture and Memory: the Spanish Jews in Macedonia and the Holocaust

Lecturer: Prof. Dr. Krinka Vidakovic-Petrov

Short Description of the Course: The course is focused on aspects of the cultural identity of the Spanish Jews in Macedonia: cultural models and transition from one to another, the role of

Messiahnism, gender perspectives, Orientalism and Westernization, ideological and political

currents (variations of Zionism, leftist ideologies, political polarization), assimilation and

integration. It further explores continuity and disruption on the eve of the Holocaust, the impact of

the Holocaust experience on identity, personal and collective Holocaust narratives, and the

transformation of living culture into cultural memory in the post-war period.

Lecture 1

Topic: The Cultural Identity of the Spanish Jews in Macedonia

Short description of the topic: From Spain to the Ottoman Balkans: the cultural identity of the

Spanish Jews. The Romaniot. Organization of Sephardic communities. Relationship with Ottoman

authorities. Jewish and Spanish elements of identity: religion, languages, written heritage, oral

tradition, customs. Cultural models.

Lecture 2

Topic: Messiahnism and Gender Perspectives

<u>Short description of the topic:</u> The Messianic tradition among Macedonian Jews. The gender perspective in social organization, education, customs and folksongs. Conformity and subversion. Variations in the feminine narrative: the ballad as a dialogic genre.

Lecture 3

Topic: Identity in Transition: Orientalism, Westernization, Zionism and Socialism Short description of the topic: The Balkan nation states: transition in the Balkan and Yugoslav framework. Change of cultural models: Orientalism versus Westernization. Macedonian Jews in Serbia and Yugoslavia. Identity issues. Emancipation. Emigration. Messianism, modern Zionism, Sephardism and political polarization. The generation gap. The Holocaust.

Lecture 4

Topic: Personal and Collective Holocaust Narratives

<u>Short description of the topic:</u> The Holocaust and after. Survivor testimonies. Collective and personal narratives. The Holocaust experience and identity in post-war Yugoslavia. Self-perception and state policies. Cultural issues. The Holocaust narrative in present-day Macedonia.

III. Course title: Genocide, the nature of the persecution and mass killing of Roma, Sinti, and

others labeled as Gypsies

Lecturer: Prof. Dr. Michael Stewart

Short Description of the Course: This course begins with conceptual and definitional questions

around the notion of genocide and the problematic notion of 'a people'. It proceeds to consider

whether a specifically anthropological approach brings something disctinctive to this field of study,

through contrasting the implications of culturalist and institutionalist explanations of genocide

within social science. On the second day we move on to consider the nature of the persecution and

mass killing of Roma, Sinti, & others labelled as Gypsies. One lecture will consider the specificity of

this genocide and the other will deal with the challenges of archival research into this field.

Lecture 1

Topic: What constitutes genocide?

Short description of the topic: Is the definition of genocide in the UN 1948 convention as "acts

committed with the intent to destroy, in whole or in part, a national, ethnical, racial or religious

group" adequate for the modern world?

Lecture 2

Topic: Assess the value of a culturalist interepretation of violence through an analysis of symbolism

embedded in act and representation.

Short description of the topic: What does a specifically anthropological approach bring to the study

of 'genocide?' What is at stake in the uniqueness of the holocaust debates? What are the

implications of culturalist and institutionalist explanations of genocide within social science?

Topic: Was there a genocide or 'merely' a persecution of the Roma and Gypsies?

Topic: How can we overcome the challenges of working with archival materials on persecution of

Sinti, Roma and Gypsies.
